1. SCOPE

- 1.1. These Terms and Conditions apply, to the exclusion of any other provision, to any registration made by a participant (a "Participant") for an event, such as a conference, course, trade show etc. organized by Europa (an "Event").
- 1.2. A copy of these Terms and Conditions can be consulted on the Event website (the "Website").
- 1.3. The registration for an Event implies acceptance, by the Participant, of these Terms and Conditions.
- 1.4. Europa reserves the right to modify these Terms and Conditions. Only the Terms and Conditions that are in effect on the day of registration of the Participant shall apply to the registration in question.

2. REGISTRATION - CONTRACT

- 2.1. Registration to the Event may be done by filling in the registration e-form on the Website.
- 2.2. The full payment of registration fee must be made at the time of registration. All payment must be in full, free of withholding and not subject to any set-off. Any registration for which either the registration form is incomplete or which does not include the payment as detailed in Section 3 below will not be considered as a valid registration.
- 2.3. Upon e-registration and receipt by Europa of full payment of the fees as detailed in Section 3, Europa will send the Participant a summary confirming his or her order and registration to the Event (the "Order Confirmation").
- 2.4. If Europa is unable to accept a registration from a Participant (i.e. late registration, availability issue, etc.), Europa will inform the Participant and refund his or her registration fee within seven (7) business days by bank transfer if payment was made bank transfer, or by credit card if the Participant paid the registration fee by credit card.
- 2.5. The contract between Europa and the Participant is formed once Europa has sent the Order Confirmation.

2.6. The Participant has the right to cancel, without cause, his or her registration within fourteen (14) calendar days of the Order Confirmation. This right of withdrawal can no longer be exercised fourteen (14) days or less before the Event. If the Participant wishes to cancel a registration, he or she must give Europa notice within the period indicated above, by filling out the standard cancellation form included at the end of these Terms and Conditions to the address mentioned in these Terms and Conditions. The registration fee will then be refunded within fourteen (14) calendar days.

3. FEES - PAYMENT

- 3.1. The fee is the amount stated at the time of the Participant's registration on the Website ("**Fee**"). Fee includes taxes. Europa may modify the Fee at any time prior to registration.
- 3.2. Fee includes all the services described on the Website.

The Participant must provide the following information as fund transfer references: name, order number and name of the Event.

The funds must be credited to Europa's account within seven (7) calendar days of registration. Otherwise, Europa reserves the right not to accept the registration and to refund the Fee to the Participant.

3.3.2. by credit card on the Website:

Payment can be made by the following credit or debit card: Visa, MasterCard and American Express. Europa may have to contact the Participant by email or by telephone to ask for additional information about the identity of the buyer and the owner of the card.

Europa's payment system has been entrusted to a service provider specializing in securing online payments that complies with the payment card industry data security standard (PCI DSS).

Fee shall be settled at once using a single method of payment.

3.4. Paid Fee can only be refunded in the events specified in these Terms and Conditions.

4. OBLIGATIONS OF THE PARTICIPANT

Registration with Europa to an Event implies acceptance of the following Terms and Conditions:

4.1. Each registration is valid only for the Event referred to in the Order Confirmation and may not be accepted for another Event.

4.2. Access conditions and control

- 4.2.1. In case of in-person participation to the Event, the Participant will receive a badge to access the Event ("Event Badge") by email before the Event or at his/her arrival at the Event venue. The Event Badge is the proof of the Participant's registration. The Participant must keep the Event Badge during the full duration of the Event and be able to present it upon request of Event security personnel. The Event Badge is nominative and non-transferable. For identification or security purposes, the participant may be asked to provide a photo upon registration and / or to present an ID card when accessing the Event.
- 4.2.2. In case of online participation to the Event, access to the platform hosting the Event is done using the usernames and passwords created by the Participant during the registration process, provided by the organizer during the registration confirmation or created by the Participant upon receipt of a personalized invitation sent by Europa. These usernames and passwords are confidential, unique, personal, and non-transferable.
- 4.2.3. The Participant must ensure the permanent compatibility of his/her technical environment with the platform used by Europa for an online Event. Technical recommendations are available on the Event Website. There shall not be any refund of Fee for non/partial-attendance of any Event including due to technical issues.
- 4.3. The Participant agrees to comply with the rules displayed on the Website of the Event or the Terms of Use for an online Event. Europa reserves the right to refuse access to the Event to any person who does not comply with this obligation.
- 4.4. The Participant also agrees to comply with any official regulation in force, including sanitary restrictions, applicable to the Event (presentation of sanitary pass, security checks, etc.). Europa reserves the right to refuse access to the Event to any person who does not comply with this obligation.
- 4.5. A Participant with a disability must check before any registration the Event accessibility. If a disability situation requiring specific accommodations is communicated after registration or revealed during the training and said accommodations cannot be put in place, the Participant may cancel the registration in accordance with subsections 5.2, 5.3 and 5.4.

5. MODIFICATIONS - CANCELLATIONS

- 5.1. Subject to this section, Europa reserves the rights, at its sole and absolute discretion, to change, postpone or delay any Event without reason:
- 5.1.1. Subject to a fifteen (15) days' notice:
 - i. Shift, advancement or postponement, not exceeding thirty (30) days from the start and end dates of the Event.
 - ii. Change of Event venue, in the case of an in-person event.
- 5.1.2. Without notice, including during the Event:
 - i. Modification of the Event program
 - ii. Modification of the start and end times of the Event.
- 5.1.3. In case of any such change, there shall be no recourse or liability against Europa.

- 5.2. If, the withdrawal period referred to in Section 2.6 having expired, the Participant wishes to cancel his/her participation in the Event, he/she must notify Europa before the Event by e-mail or mail. In this case, Europa will cancel the Event Badge or deactivate the login credentials to the online Event. In such a case, the Participant may, if he/she wishes, substitute another Participant, provided that notice is given to Europa at least 48 hours before the start of the Event.
- 5.3. Europa reserves the rights, at its sole and absolute discretion, to cancel any Event without reason and there shall be no recourse or liability against Europa. In such a case, subject to any other applicable provisions (including without limitation section 8), the following conditions will apply:
 - i. In case of total cancellation of the Event, whether in person, online or hybrid: no reimbursement will be made, and the Fee will be credited to the next edition.
 - ii. In case of cancellation of in-person participation to a hybrid event: the Fee difference between inperson and online participation will be reimbursed, based on the rate applicable to the Participant, at the date of cancellation
 - iii. In case of cancellation of online participation to a hybrid event: the online registration Fee will cover the in-person registration Fee based on the early bird rate or the amount will be credited to the next edition.
 - iv. In case of transformation of an in-person event into an online event: the paid Fee will cover the online Fee and the difference will be credited for the next edition
 - v. In case in-person participation is restricted by any government order: Europa will keep the registration for in-person participation up to the official limit on a first-come first-served basis (date of payment will prevail) and will offer following modalities to other participants registered on the date of entry into force of the gauge: If the organizational conditions allow it, online participation in the Event will be organized and reimbursement of the difference between the price paid and the price set by Europa for online participation will be made.

Europa shall, in no event, be liable for any damage or loss suffered by the Participant upon change, postponement or cancellation as aforesaid.

5.4. The amounts refundable according to Section 5.3 will be refunded, either by credit card if payment was made using a card, and by bank transfer in the other cases. The Participant shall be liable to pay any transactional or administrative charges applicable for the purpose of executing the refund. In the event the Participant is entitled to a refund by bank transfer, the Participant shall receive a notification from Europa requesting the necessary details required to execute the refund by bank transfer, to be shared within three (3) months. Should the Participant fail to provide his/her bank details within three (3) months, refund will no longer be possible.

- 6.2.
